- The option was granted on October 25, 2010, is fully vested and immediately exercisable.
- The options are exercisable at a price of C\$0.64. The US dollar price reported on this Form 3 in column 4 reflects the US dollar equivalent exercise price on the grant date, calculated at the closing price for cable transfers in Canadian dollars as reported by Yahoo Finance on such date of U.S.\$1.00 = CDN\$1.0267.
- The option was granted on December 22, 2011, is fully vested and immediately exercisable.
- The options are exercisable at a price of C\$0.40. The US dollar price reported on this Form 3 in column 4 reflects the US dollar equivalent exercise price on the grant date, calculated at the closing price for cable transfers in Canadian dollars as reported by Yahoo Finance on such date of U.S.\$1.00 = CDN\$1.0273.
- The option was granted on August 9, 2012, is fully vested and immediately exercisable.
- The options are exercisable at a price of C\$0.37. The US dollar price reported on this Form 3 in column 4 reflects the US dollar equivalent exercise price on the grant date, calculated at the closing price for cable transfers in Canadian dollars as reported by Yahoo Finance on such date of U.S.\$1.00 = CDN\$0.995.
- The option was granted on December 19, 2012, is fully vested and immediately exercisable.
- The options are exercisable at a price of C\$0.25. The US dollar price reported on this Form 3 in column 4 reflects the US dollar equivalent exercise price on the grant date, calculated at the closing price for cable transfers in Canadian dollars as reported by Yahoo Finance on such date of U.S.\$1.00 = CDN\$0.986.
- One-third of the option vested immediately, one-third of the option vested on the first anniversary of May 14, 2013, and one-third vests 18 months after May 14, 2013.
- The options are exercisable at a price of C\$0.58. The US dollar price reported on this Form 3 in column 4 reflects the US dollar equivalent exercise price on the grant date, calculated at the closing price for cable transfers in Canadian dollars as reported by Yahoo Finance on such date of U.S.\$1.00 = CDN\$1.0102.
- One-third of the option vested immediately, one-third of the option vests on the first anniversary of November 1, 2013, and one-third vests 18 months after November 1, 2013.
